### PORT READING BOARD OF FIRE COMMISSIONERS FIRE DISTRICT NO. 2 PORT READING, NJ 07064 September 6, 2022

The Board Accountant read the "Open Meeting Act" requirements. The Port Reading Board of Fire Commissioners Monthly Public Meeting of September 6, 2022 was called to order by Commissioner Santorelli at 7:00pm. All five Commissioners were present: Comm. Santorelli, Comm. Molnar, Comm. Weber, Comm. Cinelli and Comm. Eagan. Board Accountant Maria Bucsanszky was present. Board Attorney Brian Bontempo was present. Board Clerk Marianne DeSantis was present.

Minutes of the August 1, 2022 meeting were reviewed.

MOTION made by Comm. Molnar to accept the August 1 minutes, seconded by Comm. Cinelli. All in favor 5-0.

### **CAPTAIN'S REPORT:**

Captain Douglas reported on the bill that was held for "Abilitees Unlimited" last month, explaining that the amount was correct, however, it was coded wrong on the invoice and that it was for XXL shirts, not sweatshirts. Captain Douglas requested a revised invoice.

Captain Terebetsky requested permission to utilize overtime for two men on 9/12 for the Butane Drill at Shell that was rescheduled from last month. Comm. Santorelli approved the overtime.

Captain Douglas reported that they are on schedule with the equipment to mount the tablets on 9/22 and will then be coordinating the installation of the tablets. Captain Douglas looked into a tablet for the Fire Official and received two quotes from Dell for \$2000 and \$1700. Dell could not match the \$1500 that was previously approved.

Captain Douglas reported that they need an AED battery. Comm. Weber stated they should order through "Lifesavers" and that they are on backorder, but to send an email and when they receive it to replace it.

Captain Douglas reported that they have a portable radio that is not functioning and the estimated repair cost is \$355. Comm Weber requested an official quote for repair and will look into it with Operations Manager Small.

Captain Douglas requested permission to order more equipment labels.

Captain Douglas reported that they received the new hand lights. Comm. Weber requested a quote for the mounting of the lights and hooks.

Captain Douglas reported that they saw deficiencies and equipment issues at the recent turnpike incident. Captain Douglas reported on a recent demonstration of a battery-operated small combination extrication tool and that this tool would have been helpful with the bus. Captain Douglas requested that it be put on their wish list if the funds were available and order the extrication tool with two batteries and a charger through "Gunther" at a cost of \$11,000.

Captain Douglas reported that we lack incident command materials and offered his recommendations.

### **FIRE OFFICIAL REPORT:**

The Fire Official's Report was submitted and reviewed.

### TAXPAYER COMMENTS:

Jeff Kotusky, Flagstone Drive, Port Reading had an item for Executive Session.

There were no comments from the public.

#### **CHIEF'S REPORT:**

Chief reported 37 calls for the month and 241 calls for the year.

Chief reported that there would be a 9/11 Ceremony at Woodbridge High School and has requested that everyone meet at Station 2 at 12:15 pm in dress uniform.

Chief reported that the light parade will take place on 11/26 and inquired if a committee has been formed.

Chief reported that he received an email from Captain DeLeo regarding a mandatory safety officer training on 10/8 & 10/9 at the Colonia Firehouse at 0800, however it is the same day as Port Reading Day. Operations Manager Small stated that he was going to bring this up during Executive Session.

MOTION made by Comm. Weber to accept the Chief's Report, seconded by Comm. Cinelli. All in favor 5-0.

### **OPERATIONS MANAGER:**

Operations Manager Small stated that Captain Terebetsky requested overtime for two firefighters for the Butane Drill at Shell with Woodbridge Fire Dept. on 9/12 for half day, which was approved.
