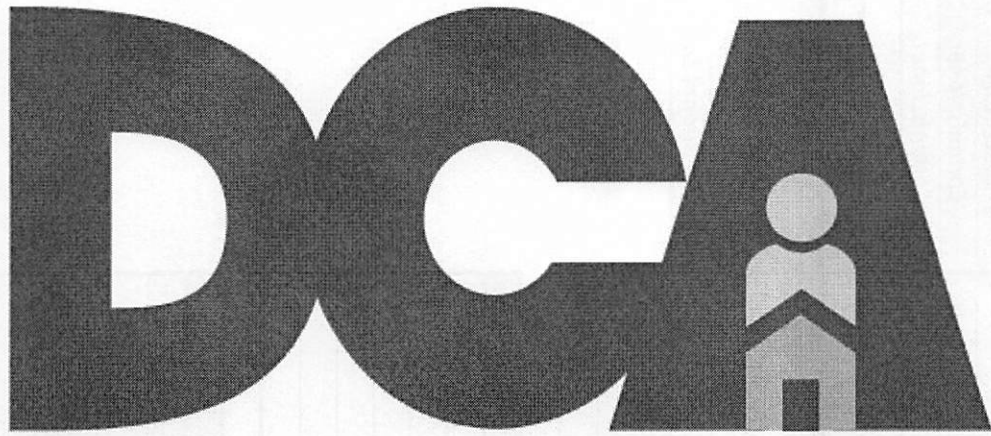

WHEREAS, the Annual Budget for Woodbridge Township FD No. 2 (the 'Fire District') for the fiscal year beginning January 1, 2024 and ending December 31, 2024 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 4, 2023; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$3,722,191.45 which includes an amount to be raised by taxation of \$3,553,614.96 and Total Appropriations of \$3,722,191.45; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 4, 2023 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2024 and ending December 31, 2024 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 8, 2024.

The District budgeted appropriations will increase \$401,684 primarily due to increased personnel costs, along with increased professional services expense as well as increased maintenance costs on buildings and vehicles. District taxes increase 8.9%.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Commissioner expense increases 20% due to increased meeting and work schedule. Administrative Fringe Benefits are reduced to be more inline with actual experience. Overall Salary & Wages, as well as associated fringe benefits for both Operations as well as Appropriations Offset with Revenues will increase a combined \$228,086 because the District will be hiring an additional 3 firefighters in 2024. Election costs increase \$6,000 due to increased meetings and elections anticipated with Capital projects. Medical /physical expenses will increase \$2,500 due to increased personnell. Legal and Engineering fees increase a combined \$64,600 due to the District exploring and estimating cost of building addition, and the exparation of collective barganing agreement in 2024. ladies Auxiliary and Fire Company expenses increase a combined \$2,200 due to increased activity by the groups to support the fire department. Uniform expense slated to increase \$3,000 due to increased hiring of personnel. First aid support increases due to additional costs of traing in this area. Maintennace and Repair - Buildings and Vehicles budgeted to increase \$22,100 based upon estimates for repair of existing vehicles as well as building repairs. Interest on deposits budeted to increase \$16,000 due to higher interest rates on larger balances of funds. E-mail maintenance cost increase slightly, and Website Coordinator cost is eliminated entirely becuae the District is eliminating the position, and will need additional help with e-mail maintenance. Revenues offset with Appropriations budgeted to increase based upon notification from NJ DCA as well as increased enforcement. This increased enforcement will require increased miscellaneous costs.

The Amount to be Raised by Taxation will increase \$289,318. The District anticipates utilizing \$\$97,534 in available Unrestricted Fund Balance.
